Keisler – Rotary Golf tournament coming up. Wants to address how much he paid for his towed truck. There is not enough funding for hazardous waste programs at the dump sites. Working on paint to paint recycle containers throughout the county. Used Tire event 17th of May from 11 to 2 p.m. Residential only 9 tires. FC met Monday all members in attendance. Discussion on public works building. 2.5 million or above range. Private lease to own options or private funding through CA banks, also a USDA option. Trying to figure out the different financing options. Still discussing rates. What is timing on construction. Soonest we could obtain financing next Spring or this fall. 6 months for construction? Audit has begun.

Discussion on demolishing buildings, within next 3—60 days. Waiting for the power to disconnect. Original cost for demo was 200k want to get it near 50K.

It's still nothing that leaders will take active leadership on. Veteran housing isn't going to happen without leadership. Wants housing to be fair for all.

Spagnola – Doesn't understand this project. Is this project going to push people out of their homes because they have vacation homes? Doesn't sound very American. Doesn't understand why folks that have a home vacant for a few months out of the year, why should they be penalized?

Closed at 7: 20 p.m.

Lucchesi – Wants to thank PWP for the additional public outreach. Wants to acknowledge that effort. Likes the direction this is going. I understand it isn't super ambitious. We don't have a large population, so it's a reasonable goal. This is first time council has been super involved with the Housing Element and Active Transportation Plan. We need more resources. Thinks this sets us up for grant funding since this process is required to obtain it. Thanks all that made public comment.

Lucchesi moves Deutsch 2nds that on the basis of the entirely of the record before us, including comments received, the proposed project could not have a significant adverse effect on the environment and is exempt from CEQA pursuant to Sec. 5061(b)(3) of the CEQA Guidelines.

Lucchesi moves Deutsch 2nds that we adopt Resolution 2024-04 for the City Council 2023-2031 Housing Element Update as Amended to Address HCD Comments.

B. Kosmont Downtown Revitalization Strategy

Rief introduces the item. Kosmont says they have updated the draft.

There is some discussion about the multifamily rents, \$363 for one unit doesn't happen here. Seems inaccurate.

? Form a committee? Let's note progress, every month, quarterly, etc. 5 strategies and action items. Very disappointed in the comments. He understands the size of city and staff. Kosmont can't do it for city, the staff and councilors are elected to do as such.

Juarez – Wants everyone to work collectively.

WHAT IS BEING ASKED OF THE CITY COUNCIL:

Actions pertaining to the summary vacation of a of a portion of the southeast corner Willow Street and Shasta Avenue:

- 1. Make a determination the action is exempt from the California Environmental Quality Act pursuant to CEQA Guidelines Sections 15031(b)(3); and
- Adopt Resolution CC-2024-06, ordering the summary vacation of a portion of the southeast corner Willow Street and Shasta Avenue pursuant to Streets and Highways Code Section 8330 et seq.

BACKGROUND/DISCUSSION:

The City of Dunsmuir is seeking approval for the vacation of a portion of land at the southeast corner of Willow Street and Shasta Avenue. The proposed vacation will eliminate excess right-of-way that is not required for street purposes. Both Willow Street and Shasta Avenue are fully constructed to the ultimate right-of-way pursuant to Figure 4-1 Circulation Map of the Dunsmuir General Plan. The proposed vacation of the portion of land identified in **Exhibit B** will not cut off access to a person's property or terminate a public service easement.

The portion of land to be vacated, which includes 5 feet adjacent to Shasta Avenue and 7 feet adjacent to Willow Street, will be incorporated into the existing development of a single-family residential dwelling unit that is currently encroaching into the public right-of-way proposed for vacation. The property to incorporate the proposed vacation is located at 4212 Willow Street with APN 058-082-010, further described in **Exhibit A – Legal Description**, and depicted in **Exhibit B – Vacation Exhibit.**

The City is not disposing of any land and therefore the Surplus Lands Act is not applicable. The vacation, if approved by Council, will become effective when the vacating resolution is recorded in the office of the Siskiyou County Recorder.

ENVIRONMENTAL FINDINGS

Pursuant to the California Environmental Quality Act (CEQA), the project is categorically exempt from CEQA pursuant to CEQA Guidelines section 15061(b)(3), because the vacation of this street is not a

project within the meaning of the California Environmental Quality since the project has no potential to cause a significant effect on the environment.

RESOLUTION CC-2024-06 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF DUNSMUIR TO VACATE A PORTION OF THE SOUTHEAST CORNDER OF WILLOW STREET AND SHASTA AVENUE ADJACENT TO 4210 AND 4212 WILLOW STREET (APN: 058-082-010)

WHEREAS, at a regularly schedule meeting on May 2nd , 2024, the City Council heard evidence for and against the vacation of a portion of the southeast corner of Willow Street and Shasta Avenue adjacent to 4210 and 4212 Willow Street; and

WHEREAS, the City of Dunsmuir holds title to that certain real property located within the City consisting of an area more specifically described and depicted in the attached Exhibit A and Exhibit B ("Property" or "Street") as attached, and incorporated, in this Resolution; and,

WHEREAS, there are no in-place public utility facilities that are in use and would be affected by the vacation; and

WHEREAS, the City of Dunsmuir has no use for the Property for street purposes; and

WHEREAS, this vacation of the street on the Property is made pursuant to the requirements of California Streets and Highways Code, Section 8330 et seq.; and

WHEREAS, Section 8330 of the California Streets and Highways Code authorizes the City to summarily vacate a street or highway, such as the Property identified in Exhibit A and Exhibit B, attached, provided it does not cut off all access to a person's property which, prior to relocation, adjoined the street or highway or terminate a public service easement, unless the easement satisfies the requirements of Section 8333; and

WHEREAS, Section 8334(a) of the California Streets and Highways Code authorizes the City to summarily vacate an excess right-of-way not required for street or highway purposes; and

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Dunsmuir as follows:

- 1. The Council finds from all evidence submitted that the vacation of a portion of the southeast corner of Willow Street and Shasta Avenue as described in Exhibit A and as shown on Exhibit B has no use for public street purposes, would not cut off access to a person's property, or terminate a public service easement.
- 2. This action is exempt from the California Environmental Quality Act pursuant to CEQA Guidelines Section 15061(b)(3) because the vacation of this street is not a project within the meaning of the California Environmental Quality since the project has no potential to cause a significant effect on the environment.
- 3. The City Clerk shall certify to the passage of this Resolution and shall file a certified copy, attested by the City Clerk under the seal of the City, in the Office of the City Clerk.
- 4. This vacation shall become effective on the date this resolution is recorded.




EXHIBIT "A" SUMMARY VACATION OF A PORTION OF WILLOW AVENUE AND SHASTA AVENUE LEGAL DESCRIPTION

Thence along the North line of said Lot 1, North 72°45'00" East for a distance of 75.00 feet to a line parallel with and distant 75.00 feet West of the East line of said Lot 1 and its Northerly projection;

Thence along said parallel line, North 17°15'00" West for a distance of 7.00 feet to a line parallel with and distant 7.00 feet North of said North Line;

Thence along said parallel line distant 7.00 feet North of said North line, South 72°45'00" West for a distance of 80.00 feet to a line parallel with and distant 5.00 feet West of the West line of said Lot 1 and its Northerly projection;

Thence along said parallel line distant 5.00 feet West of said West line, South 17°15'00" East for a distance of 57.00 feet to the Westerly projection of the South line of Lot 2 of said Block 23;

Thence along said Westerly projection, North 72°45'00" East for a distance of 5.00 feet to the Southwest corner of said Lot 2;

Thence along the West line of said Lot 2 and continuing along the West line of said Lot 1, North 17°15'00" West for a distance of 50.00 feet to the **Point of Beginning.**
